

## <u>Covid-19 Parental Agreement – Update September 2020</u>

In order to operate safely in relation to Covid-19 and to reduce the risk to our staff, children and other adults we ask that you follow and agree to the following new guidelines.

By choosing to allow your child to attend school, you are showing agreement to these guidelines.

I will not bring my child/ren to school if they or anyone within our household has or develops a fever or high temperature, a cough or loss of taste/smell.

I understand that children and staff will be monitored throughout the day. If my child develops any symptoms I will be called and asked to collect them immediately.

Only 1 adult will drop off/collect my child/ren

During drop off/collection I will adhere to social distancing guidelines and remain 2m from others.

At drop off/collection times ensure I will stick to the correct times for entering/exiting minimising bunching and grouping of adults.

I understand that my child/ren cannot bring any toys from home, in order to reduce contamination risks.

I understand that my child will be required to wash their hands at multiple times of the day or be asked to use alcohol based hand sanitiser.

I understand that my child/ren may struggle to separate from me but will allow the teaching staff to take and comfort them as necessary (and can request a follow up text or phone call to put my mind at ease)

I will dress my child in school uniform and on PE days in PE kit including trainers. My child will not be asked to change in school for PE lessons.

I will supply my child with a named water bottle that will be returned home for washing each day. Shared cups will not be offered or used.

I understand that strict cleaning schedules of surfaces and equipment will be taking place at various points of the day.

I understand that I should walk/bike or travel in my own car to travel to school. Please note the advice of Safer travel guidance. <u>Coronavirus (COVID-19): safer travel guidance for passengers</u>

I understand that I will be unable to use the school drive as it will be used as access for children to avoid bunching on the playground.

If I need to collect my child/ren at an unusual time I will phone ahead to alert the staff.

I understand that if my child/ren present challenging behaviour and staff are unable to support them, that I may be called to collect them.

I understand that socially distancing children will happen as much as possible in class bubbles of up to 30 children and a teacher.

I understand that social distancing measures are still appropriate outside of school and myself and members of my household will continue to follow Government advice regarding this.

## St Johns staff will be:

- Monitored to ensure they are not displaying Covid-19 related symptoms.
- Staff will inform management if they or anyone in their household is displaying Covid-19 related symptoms.
- All staff will be involved in regular cleaning of surfaces and equipment used throughout the day as set out in our new Covid-19 Risk Assessments
- Propping open doors (not fire doors) so that rooms can be well ventilated and avoid the use of door handles.
- Have personal mobile phones in classrooms only to call a member of the leadership team if help is required.
- Adhering to strict hand washing as set out in our new Covid-19 Risk Assessments
- Following Government advice as far as is practicable.
- Following Government advice regarding social distancing and travel when not at work.
